# GLIMPSES OF YEARS AT ICAI











Dear Colleague,

Greetings!

Representing the voices of small and medium practitioners, particularly from the mofussil areas, has been a distinct honour for me. My efforts have always been dedicated to serving the profession, members and students with the highest commitment to integrity and honesty. It was a fulfilling journey, and I truly appreciate your continued support.

After 30 years of continuous service at the Institute—spanning at the International, Central Council, Regional Council and Branch levels, I took the mandatory break as per regulations. Let me express my heartfelt gratitude for allowing me to be your council member continuously for nine years.

The lack of adequate representation for Small and Medium Practitioners (SMPs) and those from the mofussil areas engaged in individual practice, within the apex council, has led me to seek your mandate once again.

The hallmark blend of practical training and theoretical education—a key strength of the CA course—has been weakened by the reduction of the articleship period to two years. Additionally, the revised entry requirement after passing the intermediate exam has left smaller offices without students, forcing them to rely on trainees from sister institutes, inadvertently enhancing the credibility of these trainees.

Moreover, the removal of GST audit, an increase in tax audit limits, and the shift to online filing and hearings have further diminished opportunities for SMPs. The growing oversight of the National Financial Reporting Authority (NFRA) has intensified perceived risks in audit practice, leading to a disconnection between the new generation and the practice. In the era of artificial intelligence, the SMP segment is underprepared to meet the emerging challenges, largely due to a lack of coordinated efforts. It is essential to restore the profession's standing and safeguard the reputation of the Institute from being affected by isolated failures.

As Chairman of the Board of Studies, I had the privilege of securing the Council's approval for significant reforms in the course curriculum.

However, since then, some areas of concern have emerged. Core subjects like corporate law and costing have been diluted through the introduction of Self-Paced Online Modules (SPOM), which now exist outside the regular examination system.

- Revamping the course curriculum, with a focus on practical training
- Strengthening collaboration with government, regulators, and stakeholders
- Enhancing the disciplinary mechanism

The journey to complete our unfinished agendas and realise our unfulfilled dreams continues. Achieving these goals is only possible with your continued support and encouragement. I am committed to representing your interests and being your voice in the Central Council, always striving for the betterment of our profession and
